### ***Notes to Deferred Payment Form***

Defined terms used in the Deferred Payment Form and these Notes to the Deferred Payment Form shall have the meanings given to such terms in the Auction Rules, unless expressly specified otherwise.

**NOTE 1.2:** Provide the necessary details in the relevant table(s) for the respective Spectrum Right(s) provisionally awarded to the Winning Bidder. Indicate "N.A." where the details are inapplicable.

The Lower Band and Upper Band refer to the lower and upper frequencies of the spectrum band in respect of which the Spectrum Right is provisionally awarded.

The Total Spectrum Lot Fees is the sum of the Spectrum Lot Fee for each Spectrum Lot in respect of which the Spectrum Right is provisionally awarded.

The Total Application and Processing Fees is the sum of the Application and Processing Fee for each Spectrum Lot in respect of which the Spectrum Right is provisionally awarded.

**NOTE 1.4:** In accordance with Section 16.5 of the Auction Rules, this Deferred Payment Form must be submitted together with one or more Bank Guarantees for a guaranteed amount of at least 75% of the Deferred Amount for the respective Spectrum Right which must be valid until a date no earlier than thirty (30) Business Days after the respective Deferred Payment Dates. Where the Winning Bidder has been provisionally awarded both an 1800 MHz Spectrum Right (2013) and a 2.5 GHz Spectrum Right (2013) and wishes to request to defer the payment for both Spectrum Rights, the Winning Bidder may submit one or more Bank Guarantees to guarantee:

(a) an amount of at least 75% of the Deferred Amount until a date no earlier than thirty (30) Business Days after the Deferred Payment Date of the 1800 MHz Spectrum Right (2013); and

(b) an amount of at least 75% of the Deferred Amount until a date no earlier than thirty (30) Business Days after the Deferred Payment Date of the 2.5 GHz Spectrum Right (2013).

**NOTE 1.5:** The Deferred Payment Form must be signed by two directors or one director and the company secretary of the Winning Bidder, who must be clearly identified and must have authority to bind the Winning Bidder for purposes of the payment by the Winning Bidder for the Deferred Amount(s) by the respective Deferred Payment Date(s).
