# FACTSHEET Al Ethics & Governance Steering Committee

The AI Ethics & Governance Steering Committee is jointly set up today by Singapore Computer Society (SCS) and Infocomm Media Development Authority of Singapore (IMDA), with a focus to enhance the development of AI and promote AI ethics and governance in Singapore. As Singapore continues to anchor capabilities in AI, it is imperative for business owners to understand and analyse the impact of AI on social, businesses and talents, as well as learn how AI can be harnessed in a responsible way. The Model AI Governance Framework addresses business owners and decision makers and guides them in deploying ethical AI. To support them in deploying ethical AI, it is thus important to prepare IT professionals implementing AI solutions to be proficient in AI ethics and governance.

- To oversee the development of an Ethics for AI body of knowledge that will guide and govern the endorsement of AI-related training curriculum
- To build proficiency in AI ethics and governance in IT professionals implementing AI solutions for the organisations
- To foster development of a community of practice of IT professionals
- To advise on the strategies for the development of AI ethics and governance competencies for professionals
- To assist in the development of law or regulation on the ethical, transparent and accountable use of Al
- To enhance connections, collaboration and coordination among stakeholders - regulators, industry and AI community
- To keep abreast of developments in international AI standards and practice and to initiate appropriate action to safeguard and advance the interest of our society and local industry
