# REQUEST FOR INFORMATION

## Introduction

1. The [Energy Efficiency Grant \(EEG\) for the data centre \(DC\) sector](#), administered by the Infocomm Media Authority of Singapore (IMDA), was launched in December 2024. It aims to support DC end-users to transit to energy-efficient IT equipment
2. The EEG supports the adoption of **pre-approved** energy-efficient IT equipment. The pre-approved list is made publicly available on the GoBusiness website.
3. IMDA is therefore issuing this RFI to collect information on eligible IT equipment to be pre-approved under EEG. Interested vendors are invited to submit the details of qualified computer servers and storage devices to be considered for this pre-approved listing.

## Pre-approval Criteria for Energy-Efficient IT equipment for DCs

4. The pre-approval criteria for IT equipment are as follows:
  - a. Certified by ENERGY STAR<sup>1</sup> to meet the Program Requirements for Computer Servers and Storage Devices for Data Centres; and
  - b. Minimally comply to Class A2 of The American Society of Heating, Refrigerating and Air-conditioning Engineers (ASHRAE) Environmental Classes for Data Centres.
5. Please note that only IT equipment models that meet the stipulated criteria will be evaluated for pre-approved listing. IMDA has sole discretion to determine the pre-approved list.

## Submission of information

6. This RFI is a mechanism for gathering information for suitable IT equipment for data centres. It does not constitute a procurement.
7. Information must be submitted in English and written in a clear and concise manner.
