

Structural Separation and Operational Separation

Structural Separation is the stricter form of separation requirement. The Next Gen NBN NetCo is required to have no Effective Control over its downstream operators, such as operating companies and RSPs, and vice versa.

Operational Separation is the less stringent form of separation requirement. The Next Gen NBN OpCo is required to be operationally separated from its downstream operators, such as other operating companies and RSPs, and vice versa.

Table below outlines the key highlights of the separation requirements imposed on the Next Gen NBN NetCo and Next Gen NBN OpCo¹.
