INTRODUCTION

- The Code of Practice for Competition in the Provision of Telecommunication Services ("Telecom Competition Code") issued by the Info-communications Authority of Singapore ("IDA") came into effect on 29 September 2000 to ensure fair competition in a competitive environment, safeguard consumer welfare and to guide licensees on their interconnection negotiation. Under Subsection 5.3.1 of the Telecom Competition Code, the dominant licensees designated by IDA are required to submit a proposed Reference Interconnection Offer ("RIO") to the IDA within 30 days of the effective date of the Code.
- The RIO will contain a comprehensive and complete written statement of the prices, terms and conditions on which the dominant licensee is prepared to provide Interconnection Related Services to any requesting licensee.
- Singapore Telecommunications Ltd (SingTel), the designated dominant licensee, has submitted its proposed RIO on 30 October 2000 and 1 November 2000. As such, the proposed RIO is posted on IDA's website (www.ida.gov.sg) as follows:

If IDA requires an additional 15 days for its review, IDA will notify the dominant licensee prior to the 30th day.
