

SUBMISSION OF MODEL CONFIDENTIALITY AGREEMENT ("MCA")

1. Please refer to OpenNet's letter of 24 February 2009 on the abovementioned matter.
2. Pursuant to the selection of OpenNet Consortium as the Network Company ("**NetCo**") to develop the passive infrastructure of Singapore's Next Generation National Broadband Network ("**NGNBN**"), OpenNet Pte. Ltd. ("**OpenNet**") submitted to IDA for approval a proposed MCA to regulate the disclosure of information when negotiating a customised agreement for the provision of services on prices, terms and/or conditions which vary from those under the approved Interconnection Offer ("**ICO**").
3. IDA conducted a public consultation on 25 February 2009 to elicit comments in connection with the proposed ICO and the MCA. At the close of the public consultation for the proposed MCA on 9 March 2009, IDA received comments from two respondents.
4. Having carefully reviewed the proposed MCA and taking into consideration the comments received from the respondents, IDA requires OpenNet to revise certain terms of the proposed MCA before IDA grants approval.

5. Accordingly, IDA hereby requires OpenNet to comply with the following:
- a. Within seven (7) days of the date of this notification, OpenNet must submit to IDA for review and approval, its proposed modifications to the MCA to give effect to IDA's required modifications to clauses 9, 14 and 22 of the MCA and the insertion of a new clause 29 (please see enclosed explanatory memorandum to this notification). For the avoidance of doubt, to the extent that any ancillary or consequential modification to any provision in the proposed MCA is necessary in order to give effect to IDA's required modifications, IDA further requires OpenNet to propose such modification(s) for IDA's review and approval; and
 - b. In proposing modifications to the proposed MCA, IDA reminds OpenNet that:
 - i. to the extent that any of OpenNet's proposed modifications fail to effectively implement IDA's required modifications or, in IDA's view, is not acceptable, IDA will require OpenNet to incorporate specific language to the MCA; and
 - ii. IDA will reject any proposed modification by OpenNet that is not for the purpose of giving effect to IDA's required modifications as set out in this notification and accompanying explanatory memorandum.
