DIRECTION OF THE INFO-COMMUNICATIONS DEVELOPMENT AUTHORITY OF SINGAPORE: MODIFICATION OF OPENNET PTE LTD'S ("OPENNET") INTERCONNECTION OFFER ("ICO") FOR COMPLIANCE

- 1. Pursuant to the Info-communications Development Authority of Singapore Act (Cap 137A), Section 27(1) of the Telecommunications Act (Cap 323) (the "Act") and Condition 32.1 of OpenNet's Licence to Provide Facilities-Based Operations issued to OpenNet on 1 April 2009, the Info-communications Development Authority of Singapore ("IDA") hereby issues this Direction to OpenNet.
- 2. Please refer to the following documents:
 - (i) IDA's direction dated 7 May 2012, directing OpenNet to modify its proposed ICO modifications to incorporate specific drafting language in Schedules 12 (Co-Location Service), 12B (Co-Location Supplementary Cooling Service) and 15 (Charges) in relation to OpenNet's proposed Co-Location Supplementary Cooling Service under its ICO¹;
 - (ii) IDA's direction dated 27 September 2012, directing OpenNet to modify Schedule 15 (Charges) to incorporate the IDA-determined charges for Co-Location Supplementary Cooling Service; and to propose modifications to its ICO as are necessary to give effect to IDA's direction ² ("IDA's 27 September 2012 Direction"); and

- (iii) OpenNet's proposed modifications to its ICO, as submitted by OpenNet to IDA on 10 October 2012 ("OpenNet's Proposed Revised ICO").
- In its review of OpenNet's proposed modifications, IDA found the majority of OpenNet's proposed modifications to be in conformity with IDA's requirements as expressed in IDA's 27 September 2012 Direction. Nevertheless, IDA also concluded that some proposed modifications failed to give full effect to the required modifications.
- 4. Accordingly, IDA directs OpenNet to modify Schedules 15 (Charges) and 18 (Dictionary) of OpenNet's Proposed Revised ICO to incorporate the specific drafting language set out in the enclosed **Appendices** comprising:
 - (i) Appendix 1 Directed amendments to Schedule 15 (Charges); and
 - (ii) Appendix 2 Directed amendments to Schedule 18 (Dictionary) (together, the "Directed Amendments").
- 5. The grounds for IDA's determination of the Directed Amendments are annotated in the accompanying **Appendices** to this Direction.
- 6. OpenNet's Proposed Revised ICO incorporating the Directed Amendments is hereby approved by IDA ("**Approved ICO**"), and as specified in IDA's 27 September 2012 Direction, the Approved ICO will take effect retrospectively from 7 May 2012.
- 7. In connection with the above, IDA further directs OpenNet to submit to IDA, the clean softcopy of Schedules 15 (Charges) and 18 (Dictionary) of its Approved ICO within three (3) business days from the date hereof. The softcopy submission must be in both Adobe PDF and Microsoft Word formats, and emailed to IDA_ILO@ida.gov.sg. In submitting the Approved ICO to IDA, OpenNet must make all necessary editorial corrections for typographical, cross referencing and pagination errors.
- 8. Any clarification required on this Direction must be made in writing, addressed to our Ms Aileen Chia (Deputy Director-General (Telecoms & Post)), and emailed to IDA_ILO@ida.gov.sg. Please note that any query or clarification from OpenNet shall not affect OpenNet's

obligation to comply fully with this Direction, including, in particular, the timelines to be complied with.
