SCHEDULE 3 CHARGES – GENERAL CONDITIONS

GENERAL:

- (a) AAT agrees to pay the following Charges in accordance with clauses 5 & 6 of the main body of this Agreement, and the Billing and Settlement requirements set out in Schedule 4.
- (b) Except where otherwise indicated, if Charges are expressed to be estimates in this Schedule or elsewhere in this Agreement, SingTel reserves the right to adjust these Charges from time to time, and AAT agrees to pay SingTel's Charges as adjusted from time to time.
- (c) If SingTel incurs costs in addition to these Charges in providing IRS under this Agreement, SingTel reserves the right to recover its costs in addition to the Charges below, and AAT agrees to pay such costs.

1. SCHEDULE 1 –VIRTUAL INTERCONNECTION

1.1 Interconnect Testing

In the provision of SingTel’s facilities and engineering support for the Interconnect Testing and the eventual connection to SingTel Network, AAT shall pay SingTel the Charges based on the testing duration inclusive of any extension period, as set out below.

1.1.2 Extension of interconnect testing

The Charges for any testing period will be inclusive of any extension requested by AAT.

1.1.3 Call fees during interconnect testing

All calls made during interconnect testing shall be chargeable to AAT at the applicable commercial rates for the conveyance of calls in accordance with Schedule 2 and as outlined below.

1.1.4 Cancellation of Interconnect Testing

Any request for cancellation of Interconnect Testing shall be made in writing to SingTel and AAT shall pay SingTel the cancellation Charges as follows, depending on the number of calendar days (from the receipt of the cancellation notice to the date of commencement of testing):

Number of days:	% of Testing fee to be paid:
<7	100%
7-13	80%
14-20	35%
>21	20%

1.1.5 Delay or cancellation of Connection Testing

AAT is liable for all Charges that may arise from any delay or cancellation of Connection Testing if the Connection Agreement is not executed prior to the test.

1.1.6 Completion or termination of connection testing

In the event that interconnect testing is completed or is terminated by AAT before the last day of the agreed testing period, AAT shall pay SingTel the Charges for the unused duration from the next Working Day after the completion or termination of interconnect testing to the last day of the testing duration. In which event testing shall terminate on the day on which testing was completed or terminated and SingTel shall not be obliged and shall not be required to effect any further testing for the remaining testing duration.

1.2 Recovery for over-forecasting

1.2.1 The cost recovery for over-forecasting shall be based on the number of 2M circuits augmented in the Interconnect link and SingTel Network to meet the committed forecast.

1.2.2 The Charges shall be as follows:

2. SCHEDULE 2 – CALL ORIGINATION

2.1 General

- 2.1.1 The below rates shall be based on circuit utilisation from the time the circuit is seized until the time the circuit is released. The Charges shall be accounted in per minute blocks. All calls whether successful or unsuccessful shall be charged.
- 2.1.2 The “Off-Peak Hour Rate” is applicable to the period of time between 1800 hours and 0800 hours, Monday to Friday and all day Saturday to Sunday inclusive, and gazetted public holidays. The “Peak Hour Rate” is applicable to the period of time between 0800 hours and 1800 hours, Monday to Friday inclusive, but not including gazetted public holidays.

SCHEDULE 2A - ORIGINATION

- 2.2 Call Charges Payable by the Parties for Call Origination Service shall be as follows for all calls:
