Notes to Deferred Payment Form

Defined terms used in the Deferred Payment Form and these Notes to the Deferred Payment Form shall have the meanings given to such terms in the Auction Rules, unless expressly specified otherwise.

NOTE 1.2: Provide the necessary details in the relevant table(s) for the respective Spectrum Right(s) provisionally awarded to the Winning Bidder. Indicate "N.A." where the details are inapplicable.

The Lower Band and Upper Band refer to the lower and upper frequencies of the spectrum band in respect of which the Spectrum Right is provisionally awarded.

The Total Spectrum Lot Fees is the sum of the Spectrum Lot Fee for each Spectrum Lot in respect of which the Spectrum Right is provisionally awarded.

The Total Application and Processing Fees is the sum of the Application and Processing Fee for each Spectrum Lot in respect of which the Spectrum Right is provisionally awarded.
