eUICC Subscription Management Technology (SMT) – Consumer Device

1 Scope

- 1.1 This Technical Specification (TS) sets out the configuration requirements for implementing Remote SIM Provisioning (RSP) based on the GSMA Consumer RSP Architecture and Technical Specification (GSMA SGP.21 [1] and GSMA SGP.22 [2]).

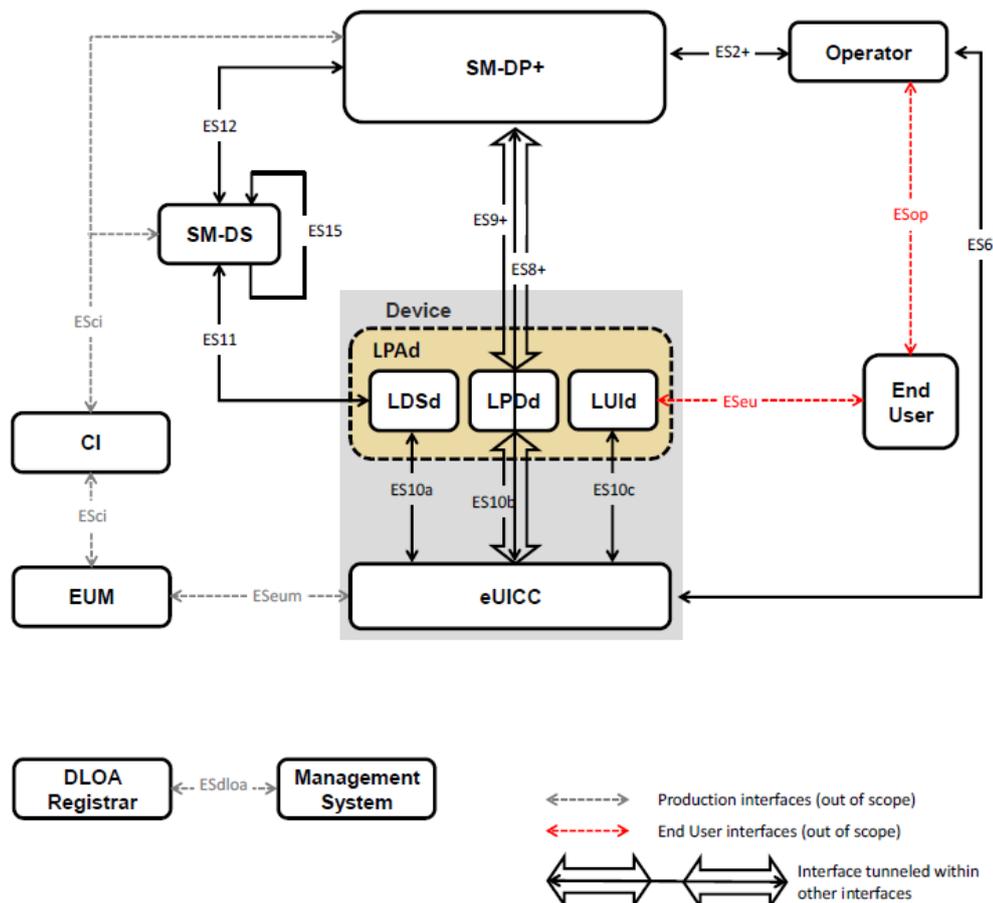


Figure 1: Remote SIM Provisioning System, LPA in the Device (Figure 1 of GSMA SGP.22 [2])

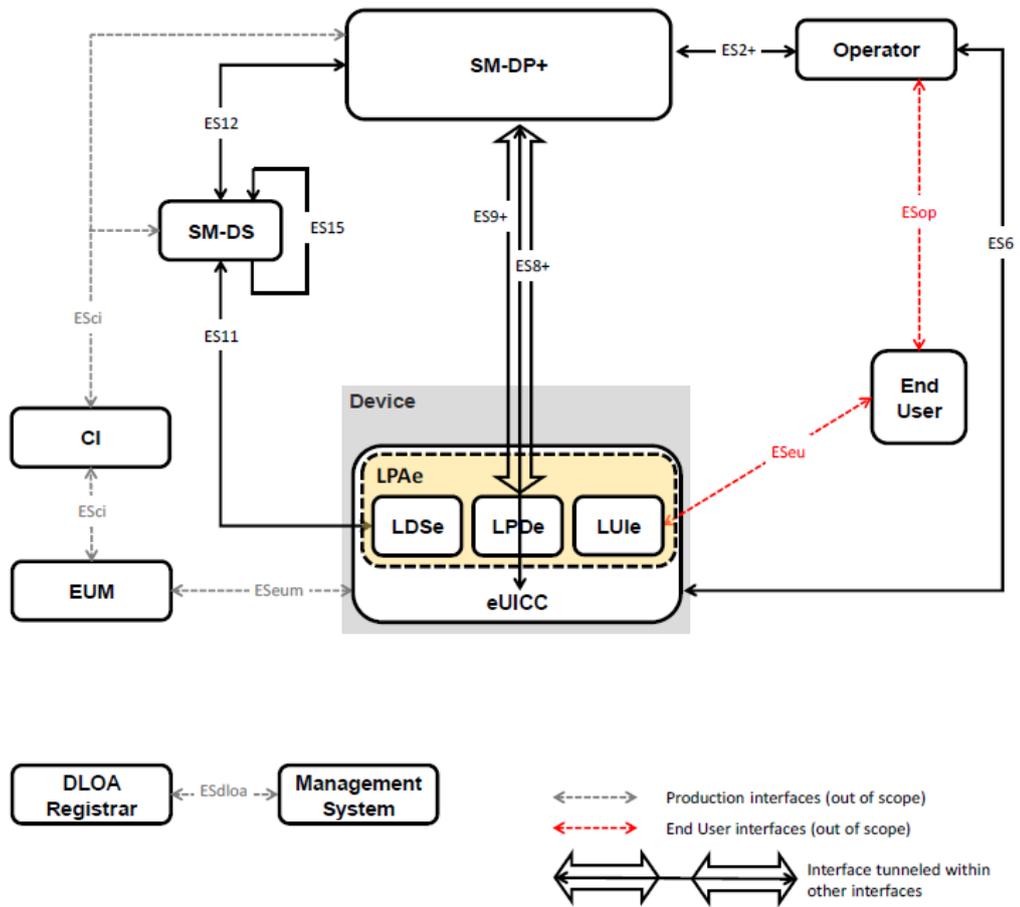


Figure 2: Remote SIM Provisioning System, LPA in the eUICC (Figure 2 of GSMA SGP.22 [2])

- 1.2 The scope of this TS focuses on the Consumer Device as shown in Figure 1 and Figure 2, extracted from the GSMA SGP.22 [2] specification. Separate configuration requirements for the Consumer Server are set out in section 5 of the IMDA Provisioning of eUICC Subscription Management (IMDA Provisioning of eUICC SM).
- 1.3 Subscription management for the Consumer Device is pulled by the End User via a Local Profile Assistant (LPA) after obtaining commercial agreement from the Service Provider, unlike the M2M Device, where Subscription management is pushed from the M2M Server. The LPA MAY be located in the Consumer Device or the eUICC as shown in Figure 1 and Figure 2, depending on the use-case.
- 1.4 The Consumer Device MAY comprise a primary and a companion device, for example, where the LPA is located in the primary device (mobile) and the eUICC is in the companion device (wearable).

2.2 Conventions

The use of "SHALL", "SHALL NOT", and "MAY" in this TS infers the following (RFC 2119 [10]):

- a. SHALL means "REQUIRED", a Mandatory requirement;
- b. SHALL NOT means "MUST NOT"; and
- c. MAY means an Optional requirement.

3 Definitions and Abbreviations

For the purpose of this TS, the following terms and definitions apply (taken mainly from GSMA SGP.22 [2]).

3.1 Definitions

Consumer Device: Device that supports Remote SIM Provisioning as defined by GSMA SGP.21 and SGP.22.

Device: User equipment used in conjunction with an eUICC to connect to a mobile network. E.g. a tablet, wearable, smartphone or handset.

eUICC: A removable or non-removable UICC which enables the local management of Profiles in a secure way.
Note: The term originates from "embedded UICC".

It is a UICC that supports "over the air" provisioning of an initial subscription and the subsequent change of subscription from one operator to another in accordance with GSMA specifications for RSP.

Local Profile Assistant (LPA): A functional element in the Device or in the eUICC that provides the Local Profile Download (LPD), Local Discovery Services (LDS) and Local User Interface (LUI) features. When the LPA is located in the Device, they are called LPA_d, LPD_d, LUI_d, LDS_d. When the LPA is located in the eUICC, they are called LPA_e, LPD_e, LUI_e, LDS_e. Where LPA, LPD, LDS or LUI are used, they apply to the element independent of its location in the Device or in the eUICC.

Operator: A Mobile Network Operator or Mobile Virtual Network Operator; a company providing cellular mobile network services.

Profile: A combination of data and applications to be provisioned on an eUICC for the purpose of providing services.

Server: Either an SM-DS or SM-DP+.

Service Provider: The organization through which the End User obtains PLMN telecommunication services. This is usually the Network Operator or possibly a separate body.

Subscription: Describes the commercial relationship between the End User and the Service Provider.

UICC: It is the hardware used in mobile devices that contains SIM and/or USIM applications enabling access to GSM, UMTS/3G and LTE networks.

4 General Requirements

- 4.1 For access to Public Land Mobile Network (PLMN) services, the Consumer Device SHALL comply with the IMDA Technical Specification for Cellular Mobile Terminal (IMDA TS CMT [8]), and SHALL support E-UTRAN (Annex C of SGP.22 [2]).

5 Consumer Device Requirements

- 5.1 At minimum, the Consumer Device SHALL be PTCRB or GCF certified as sufficient proof of compliance with GSMA's Remote SIM Provisioning specification, comprised of the GSMA SGP.21 [1] and the GSMA SGP.22 [2] Specifications. The Consumer Device SHALL comply with the applicable mandatory functional device requirements listed in Annex C of the GSMA SGP.22 [2].
- 5.2 Vendors of Consumer Devices and their eUICC Suppliers SHALL ensure that the required eUICC compliance declarations and certifications comply with GSMA's RSP Compliance Process for the GSMA Consumer RSP Architecture and Technical Specification (GSMA SGP.24 [4]), which include:
- a. eUICC functional testing performed according to the RSP Test Specification (GSMA SGP.23 [3]);
 - b. eUICC security evaluations performed according to the eUICC for Consumer Devices Protection Profile (GSMA SGP.25 [5]);
 - c. eUICC hardware platform certified to Security IC Platform Protection Profile with Augmentation Package Certification (PP-0084) or Security IC Platform Protection Profile (PP-0035); and
 - d. Production sites for eUICCs used in the Consumer Devices accredited according to the SAS-UP (GSMA FS.04 SAS-UP [6] and GSMA FS.05 SAS-UP [7]).
- 5.3 No SIM Lock

The Consumer Device SHALL be enabled to provide for new Profile download and swapping by the End User. In the event that the Consumer Device comes with a pre-loaded Profile, the Device SHALL NOT prevent the End User from downloading a new Profile and subsequently, enabling that Profile for usage.
