## CONDITIONS OF FILM EXHIBITION (RESTRICTED) LICENCE

- 1. In this Licence:
  - (a) unless the context otherwise requires, any word or expression used in this Licence shall have the same meaning as it has in the Films Act 1981 (the "Act"); and
  - (b) "age-restricted film" means any film that has a classification rating of NC16 and above.
- 2. The Licensee shall only publicly exhibit films:
  - (a) within the scope of the Licence;
  - (b) within the period of the Licence; and
  - (c) at the place(s) approved in the Licence for public exhibition of films and such other place(s) as may be approved in writing from time to time by a Licensing Officer (collectively, the "Approved Place(s)").
- 3. The Licensee shall not publicly exhibit or permit the public exhibition of any agerestricted film at the Approved Place(s) to any person below the age to which the relevant restriction applies.
- 4. The Licensee shall put in place effective age-verification measures to ensure that it complies with Condition 3 above.
- 5. The Licensee shall:
  - (a) throughout the period of the Licence, maintain a register recording the titles, quantities, dates of purchase and classification certificate numbers of all films purchased or otherwise obtained by the Licensee for exhibition at the Approved Place(s) (the "Register");
  - (b) retain the Register for a period of 3 months after the expiry of the Licence; and
  - (c) if required to do so, produce the Register for inspection by a Licensing Officer, Classification Officer or Enforcement Officer at any time upon request.



- 6. The Licensee shall not assign, transfer, sublet, or otherwise dispose of this Licence, or any of its rights, duties, liabilities, obligations and privileges under this Licence, to any person without the prior written consent of a Licensing Officer.
- 7. The Licensee must keep a copy of this Licence at every Approved Place and shall, if required to do so, produce it for inspection by a Licensing Officer, Classification Officer or Enforcement Officer at any time upon request.
- 8. The Licensee shall notify the Authority of any changes to the information in the Licence including and not limited to changes in the particulars of the Licensee, the Licensee's Representative and the Approved Place(s). Such notification shall be provided to the Authority no later than 7 days from the date of the relevant change. For the avoidance of doubt, this Condition does not permit the Licensee to assign, transfer, sublet or otherwise dispose of the Licence to any other party or to change the location of any Approved Place(s) or any part thereof, without the prior written consent of a Licensing Officer.
- 9. The Licensee shall not, directly or indirectly, by himself or by any other person in any manner whatsoever influence or attempt to influence any decision of a film content assessor in relation to the classification of any film.
- 10. The Licensee shall provide to the Authority by Licence Commencement Date,
  - (a) a security deposit of \$20,000; or
  - (b) in lieu of paying such security deposit in cash, a banker's guarantee in the format specified at **Annex A**,

to secure the obligations of the Licensee under this Licence, the Act and its subsidiary legislation in accordance with Section 8 of the Act.
